TWYs, Parking Stands status incorrect

Jeppesen Airport Moving Map and A816 formatted data for cycle 2408, effective 08 August 2024, contains incorrect data for Incheon Intl; Seoul/Incheon, Korea (RKSI). Korea AIP SUP 35/24, effective 25 July 2024, introducing "Construction Work for Passenger Terminal 2 extension" was received after 2408 AIRAC cycle data processing due date, therefore following changes are not reflected in 2408 data:

Effective 16:00 [UTC] on 20 August 2024:

- TWY A16 (between TWY A and TWY R1) is opened
- TWY M16 (between TWY M and TWY R4) is opened
- TWYs RE, RW, R22-R25 are opened
- TWY R1 (between Stand 281 and TWY R17) is opened
- TWY R4 (between Stand 218 and TWY R17) is opened
- Parking Stands 208-222, 224, 225 are opened
- Parking Stands 268, 268R, 275-291 are opened
- Parking Stands 506, 507 are opened
- Parking Stands 516, 517 are opened

Affected Low Visibility Procedures:

- RWY 15L/R, 16L/R SMGCS – Arrival Taxi Route (AIP RKSI AD 2-29)
- RWY 33L/R, 34L/R SMGCS – Arrival Taxi Route (AIP RKSI AD 2-30)
- RWY 33L/R, 34L/R SMGCS – Departure Taxi Route (AIP RKSI AD 2-31)
- RWY 15L/R, 16L/R SMGCS – Departure Taxi Route (AIP RKSI AD 2-32)
